



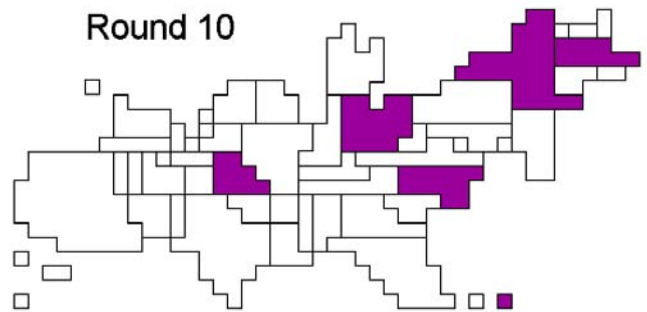
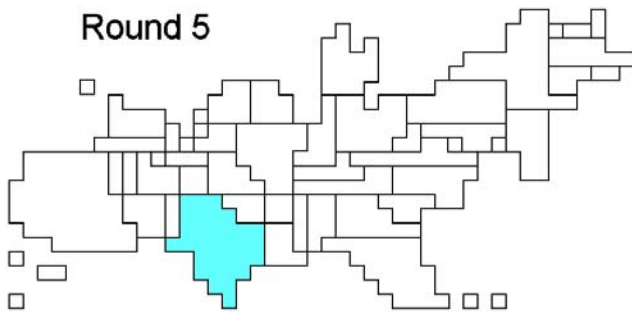
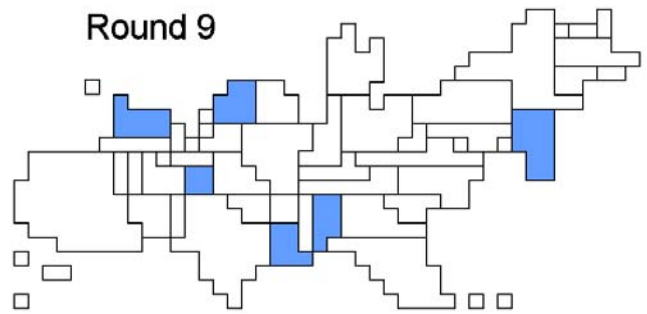
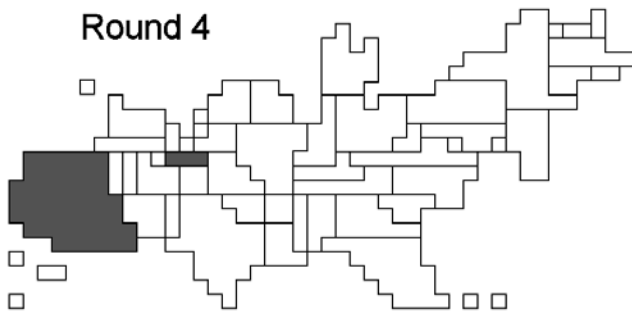
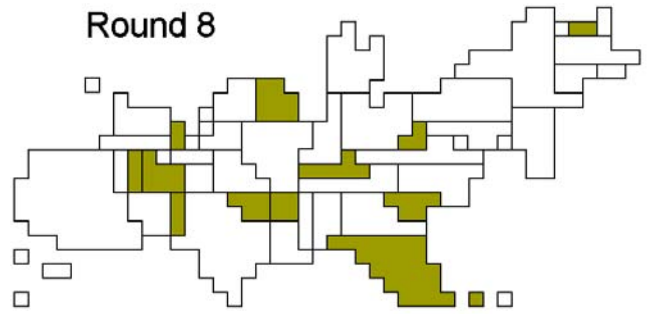
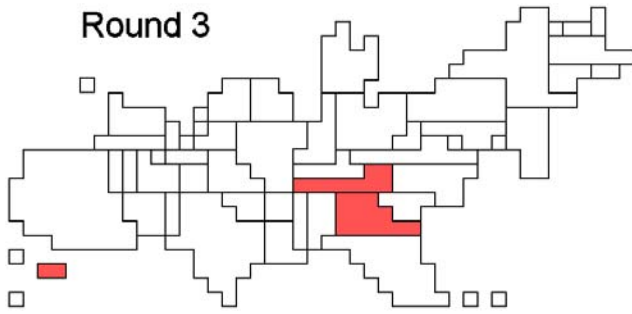
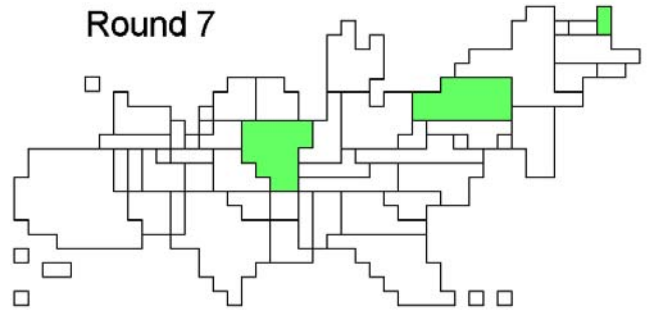
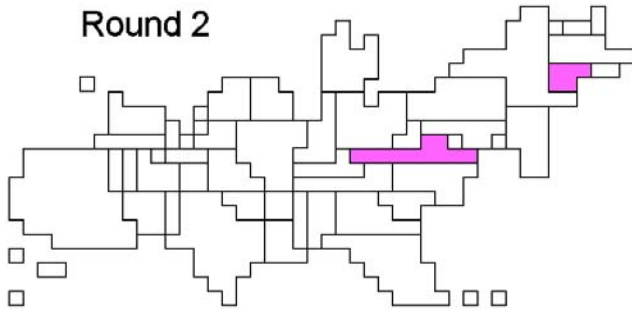
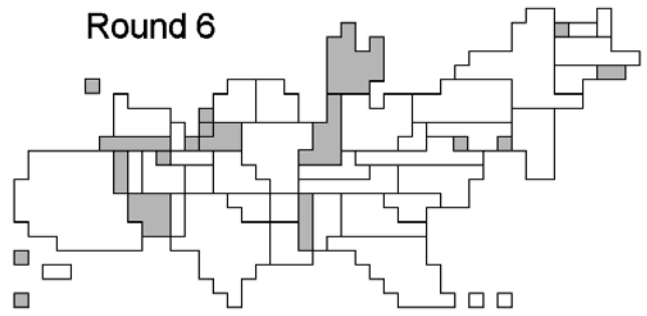
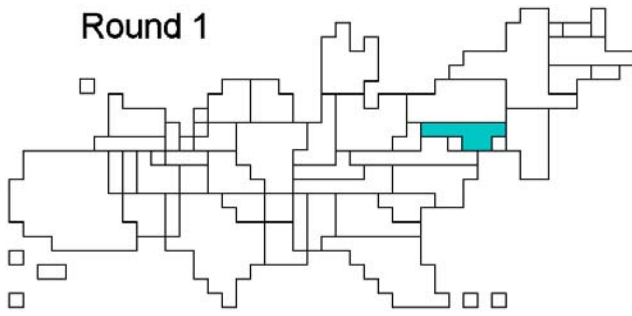
2012 Sample Schedule

Below is a possible schedule for 2012. It demonstrates that ethnically diverse, low-population states such as Maryland, Virginia, Georgia, and Hawaii can participate at the beginning of the process. At the same time, populous states such as California and Texas may be scheduled early in the calendar. In any case, because the schedule is spread out and many convention delegates are selected in the later rounds, even the states toward the end of the calendar may have a significant impact on the outcome of the campaign.

In 2016, the order of the states would be completely different. Perhaps Wisconsin would be in Round 1, Massachusetts and South Carolina in Round 2, Kentucky and Ohio in Round 3, *et cetera*.
